Regular Council Meeting
Tuesday, January 09, 2018

With a quorum present, Mayor Eddie Ford called the City of Jenkinsburg's Council meeting to order at 7:00 pm. Attending were Mayor Pro-Tem Kenneth Rooks, Council Members: Jason Watts, Joye England, Susan Barabas, and City Clerk Clair Jones.

Adopt Agenda - A motion was made by Jason Watts to adopt the agenda as presented for the January 9, 2018 meeting. The motion was seconded by Kenneth Rooks. Council voted: Jason Watts - yes, Joye England – yes, Kenneth Rooks – yes, and Susan Barabas - yes. The motion passed.

Approve Minutes from the December 11, 2017 Meeting - A motion was made by Kenneth Rooks to approve the minutes from the December 11, 2017 meeting as presented. The motion was seconded by Jason Watts. Staff Report – The City Clerk reported Billy Sorrow and Kim Reese would be attending a Chemical Spill Class Jan. 10, 2018. This is an annual training they attend. She also reported the office staff is working on records retention and destroying outdated files. The Mayor asked the council if they had any objection of Mr. T.E. Robison donating the remainder of the land he owned on Hwy 42 and Kudzu Rd. to the City. There were no objections and the council was very appreciative of the donation.

90 Day Moratorium on Zoning Decisions. The Mayor explained that the Planning and Zoning Commission had met to hear a rezoning request and the commission decided they would like to make changes to the permitted use, Table 8, of the city's Zoning Ordinances before making a recommendation to the council on the rezoning. A motion was made by Kenneth Rooks to impose a 90 day moratorium on all zoning decisions. The motion was seconded by Joye England. Council voted: Jason Watts - yes, Joye England – yes, Kenneth Rooks – yes, and Susan Barabas - yes. The motion passed.
